# CE Marking What it all really means **!!!**

From 1<sup>st</sup> July 2013, the Construction Products Regulation (CPR) came into force, requiring that companies manufacturing and installing Industrial Roller Shutter Doors (excluding Fire Shutters), must do so to the harmonised standard EN13241-1-1:2003 & A1:2001.

This means every shutter (excluding Fire Shutters), must possess a Declaration of Performance (DoP) and carry a CE mark based on the doors performance.

Some companies have employed experts to get them through the process, whilst others have decided to simply stop manufacturing rather than go through the pain of CE marking. Many companies have done nothing, trying to decide which is the best option for them and their business.

There are some useful documents available that will give you a guide to what is required and what you have to do to achieve those requirements.

We have spoken directly with the Construction Products Association who have been extremely helpful with their guidance, and have a helpful and easy to read "Guidance Notes on the Construction Products Regulation" which can be downloaded free of charge from their website at http://www.constructionproducts.org.uk

This is our interpretation on the regulations.

- 1) CE Marking is against Annex Z and not the whole EN13241 standard.
- 2) The Specifying Requirements are composed of 10 Essential Characteristics of which only 3 require a Declaration and a Notified Test Laboratory.
- 3) The 3 Characteristics that do require a declaration are, Dangerous Substances, Safe Opening (for vertically moving doors), and Operating Forces (for power operated doors).
- There are 5 systems of AVCP, a term applied to define the degree of involvement of 3<sup>rd</sup> parties in assessing conformity.
- 5) Companies with less than 10 employees and a turnover of less than €2m Euro's do not require and external assessment body for Systems 3 & 4 although they must perform in house self-certification.

All in all the new regulations are not as daunting as you might initially think. The key to ensuring you are covered is to make sure you follow the regulations, that a CE Certificate and Label are fixed to your shutter and use only quality genuine "CE" Marked products.

NVM only use and supply quality products that conform to all the EU regulations. All our motors and electrical products conform to either CE or TUV requirements whilst all the raw materials we use conform to the required British Standards. This includes our castings and all of our machines steel components.
